CURRENT COGGINS MUST ACCOMPANY ENTRY TO BE COMPLETE (within 12 months) **Add a \$30 late fee if your entry is received after the closing date (May 27).**

Stabling: Limited on grounds - \$75. No bedding provided. Bagged shavings may be purchased for \$9 per bag. Please send in a **separate \$30 clean stall deposit check payable to Cobblestone Farms 6301 Gregory Rd. Dexter MI 48130;** check will be torn up if the stall is stripped after use. **Please put rider and horse name on check. If to be stabled in a group, all riders must use same group name when requesting stalls together. Please sanitize your area and wear masks.**

Parking: ALL TRAILER PARKING IS AT 5601 ZEEB ROAD.

Directions to Cobblestone Farms: GPS – use 5601 Zeeb Road, Dexter, MI

ALL TRAILER PARKING IS AT 5601 ZEEB ROAD.

Coming from the East: Take 94 west or M-14 to 23 north towards Brighton. Go to exit 49, North Territorial Road. Turn west and go about 5 miles to Zeeb Rd. Turn south (left) and go past first stop sign (Gregory Rd.) and proceed ¼ mile to 5601 Zeeb, driveway on west side of road.

Coming from the North: South on 23 to exit 49, North Territorial Rd. Follow directions from above.

Coming from the South: North on 23 to exit 49, North Territorial Rd. Follow directions from above.

Coming from the West: Take 94 east to Zeeb Rd, exit #169. Go north (left) about 3 miles to Joy Rd. Turn left then quick right back onto Zeeb Rd. Continue north for about 2 ½ miles to 5601 Zeeb, driveway on west side of road.
